Take home message 1

Knowledge and Technology Transfer, Innovation Policy

Take home message 2



Commercialization of research results and transfering the knowledge are parts of the university's mission.

We have to ensure that the knowledge gets out of the ivory tower for the benefit of society.

Technology Transfer is a highly non-linear complex and case by case process which needs time, know-how, commitment and communication.

We must help our students to develop their entrepreneurial skills so that they are better prepared for their future career.

Knowledge Transfer needs professionals to assist the process, but can hardly be done without the researchers' involvement.
