## **Bilateral agreements**

Both signatories as per accord agree that the cooperation shall be carried out based on a **yearly program of cooperation** 

The Doctoral Programme and its phases will be further specified by the signatory universities. Each action implemented is to be defined by specific mutual or individual contracts.

Both universities shall agree upon the forms and manners of cooperation.

Both parties agree that all the **financial arrangements should be negotiated and will depend upon the availability of funds**.

The two institutions agree to seek financial support from national and international organizations for the activities and exchanges to be undertaken in the terms of this agreement.
